Ms. Abraham's areas of expertise include program development, grants management, and stakeholder engagement skills developed as a grants manager in both Maryland and Washington D.C. She earned her bachelor's degree in criminal justice from Coppin State University, MD, and a master's in political science from Bowling Green State University, OH.
